- d) All the Presiding Officers, before whom the new appointees have to join, are directed to get the character and antecedents of the new appointees verified from the concerned authority.
- e) The new appointees are directed to give an undertaking before the Presiding Officer at the time of their joining in the shape of affidavit duly attested by the Judicial Magistrate 1st Class to the effect that in case any adverse report about his/her character and antecedents is received from the concerned authority, in that event his/her appointment shall be deemed cancelled ab- initio and shall have no claim on his/her appointment.
- f) The salary of the new appointees shall not be drawn unless a satisfactory report in respect of (c), (d) & (e) above is received by the concerned Presiding Officer.
