Instructions:

- I. Candidates are advised to reach the examination center at least one hour before the scheduled time.
- II. The candidates along with their admit cards shall also carry with themselves identity proof like Adhaar card, Election Card, Driving license, Passport etc.

- III. For writing in the examination, only ball pointed pen preferably of blue colour will be allowed in the examination center.
- IV. No electronic gadget like Mobile Phone, Tab, Calculator, Smart watch etc. will be allowed in the examination center. If any candidate is found with any type of electronic gadget in the examination center, same shall be treated as unfair means and such candidate shall lose his candidature.
- V. No TA/DA Shall be paid to the candidates.
