The Hon'ble High Court, Madras has implemented mandatory e-filing of cases (N.I Act Cases) and further extended the mandatory e- Filing to other case type in District Judiciary and the same has been mandated in Ramanathapuram District as per the references cited above.

Now, the Hon'ble High Court, Madras has proposed to change the Version of e-Filing 1.0 to e-Filing 3.0 which is having more facilities, in the Principal Seat at Madras High Court, Madurai Bench of Madras High Court and in the Subordinate Courts in the Sate of Tamil Nadu and U.T. of Puducherry.

In this regard , necessary training towards e-filing 3.0 is to be given to the Judicial Officers, Staff Members, Advocates and Advocate Clerks twice the month from January 2024 to March 2024 as instructed by Hon'ble High Court Madras.

In this regard, Thiru. G.Prabakaran, Judicial Magistrate No II, Ramanathapuram and Thiru.S.Arun Shankar Judicial Magistrate, Mudhukulathur is hereby informed to co-ordinate the training to the Advocates and Advocate Clerks in e-filing of cases in the below mentioned date.

Further it has been proposed as per the direction of the Principal District Judge, Ramanathapuram for the month of January, all the Advocates and Advocate Clerks of Ramanathapuram Bar Association are required to attend the e-filing training programme at the Bar Association, Ramanathapuram on 31.01.2024.
