With reference to the Subject, the Hon'ble High Court, Madras has proposed

to extend the facility of mandatory e-Filing of Second Appeal, Criminal Appeal and all Bail Applications and all Criminal MPs dealing with relaxation of condition, extension of time for furnishing sureties and modification of Bail Condition, etc., in the Madras High Court, Madurai Bench of Madras High Court and to the **Bail Applications and its allied matters**, **Partition Suits, Mortgage Suits, Eviction Suits, Suits for Possession, Pre-emption Suits, Suits for Accounts, Suits for dissolution of Partnership and Specific Performance Suits in the District Judiciary on and from 01.04.2024.** 

Further, in this regard, the Hon'ble High Court, Madras has issued a Notification towards extending the facility of mandatory e-Filing of cases to the said case types from 01.04.2024 and the same has been hosted in the Official Website of Hon'ble High Court of Madras.

As directed, all the Judicial Officers in Ramanathapuram District are hereby instructed to implement e-filing of cases to the said case types from **01.04.2024 mandatorily** and not to take the cases if filed through physical mode on file and not to insist the filing of physical copies. Further all the Judicial Officers in Ramanathapuram District is instructed to give necessary instructions to all the staff concerned for scrutinizing the **Bail Applications** and its allied matters, Partition Suits, Mortgage Suits, Eviction Suits, Suits for Possession, Pre-emption Suits, Suits for Accounts, Suits for dissolution of Partnership and Specific Performance Suits in the District Judiciary filed through e-filing without any delay.

Further the System Analyst of this court is hereby instructed to host the said Notification in the District Court Website and sensitizing the Advocates towards e-filing facility.

Further the Presidents of all Bar Association in Ramanathapuram is instructed

to give necessary instructions to the Advocates of their Bar Association for filing of the above said cases through e-filing only and not to file in physical mode.
