

- IT knowledge with proficiency in work.

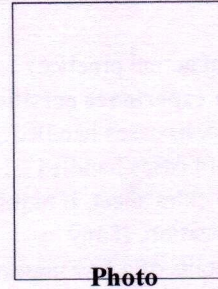
