

They should issue necessary orders giving directions to their staff members to remain present for attending the urgent work.
- 3) The Additional Sessions Judges with whom charge is kept are required to attend the remand work of Pocso Cases, ACB, NDPS and offences under all the other special Acts except M.C.O.C.
- 4) The Judicial Officers who are permitted to leave head quarter during the said period to instruct the staff working in their respective courts/establishment to make themselves available in case of emergencies during the said period.
- 5) In case of any emergency if the charge arrangements is changed. The new arrangement and the contact number of the concern responsible officer must be provided to avoid inconvenience.
- 6) Charge of hoilday remand dated 23/12/2023, 24/12/2023, 25/12/2023 & 31/12/2023 will be continued as per remand arragement of concerned Taluka Courts.
