3. The recruitment to the said posts shall be made in accordance with the Telangana State Judicial (Service and Cadre) Rules, 2023, as amended from time to time.

Note:- The reservation in respect of BC-E (Socially and Educationally Backward Class (E) category shall be subject to the result of Civil Appeal Nos.2628-2637 of 2010, on the file of the Hon'ble Supreme Court of India.

#### 4. ELIGIBILITY:

The applicant for the above said post shall be,

a) A practicing Advocate in the High Court for the State of Telangana or Courts working under the control of the High Court for the State of Telangana for not less than 7 years as on the date of notification.

**Note:** Full time salaried Law Officer in the employment of the Central Government or State Government or any Public Corporation or Body constituted by statute, shall not be eligible.

- b) A person, who has completed 35 years of age and not completed 48 years of age as on the date of the notification inviting applications for such appointment is published in the newspapers. Upper age limit is relaxable by 3 years in respect of the applicants belonging to the Scheduled Castes, Scheduled Tribes, Backward Classes (nomenclature modified as "Socially and Educationally Backward Classes".
- c) A person who has good character and is free from any disability, which renders him/her, unfit for such appointment.

No person shall be eligible for appointment to the category if:

- i) He / She is not a citizen of India;
- ii) He / She is dismissed from service by any High Court;
- iii) He / She has been convicted of an offence involving moral turpitude as defined in the Conduct Rules;
- iv) He / She is or has been permanently debarred or disqualified by the High Court or Union Public Service Commission or any State Public Service Commission from appearing for examinations or selections conducted by it;
- v) He / She directly or indirectly influences the recruitment authority by any means for his / her candidature;
- vi) Has more than one spouse living, and
- vii) marries knowingly a person having a spouse; and

- viii) Has committed any act of copying or misconduct during the course of screening test / written examination or has been convicted in a criminal case or is compulsorily retired, removed or dismissed from Judicial Service or any other service or could not successfully complete probation period of any post in Judicial Service or any candidate who from own volition sought discharged from Judicial Services.
- d) The decision of the High Court as to the eligibility or otherwise of a candidate for admission to the written examination and viva-voce shall be final. Only candidates who are issued with hall tickets shall be admitted for the examination.
- e) The candidates applying for the posts of District Judge (Entry Level) under direct recruitment, must be able to read, speak and write the Telugu language fluently and shall pass test as may be prescribed by the High Court.

#### 5. RESERVATION:

- a) The recruitment shall be subject to the Rules 22 and 22-A of the Telangana State and Subordinate Service Rules, 1996 in so far as they relate to S.Cs., S.Ts., B.Cs., Economically Weaker Sections, Women and four percent for Differently-abled persons in the specified order of rotation as per the Telangana State Judicial (Service and Cadre) Rules, 2023.
- b) For the aforesaid purpose, the community of the candidate shall be recognized as BC/SC/ST as the case may be, in the State of Telangana as per G.O.Ms.No.196, dt: 28-5-2016 and G.O.Ms.No. 3, dt: 9-9-2020. Otherwise, the candidature of applicant will be rejected.
- c) The horizontal reservation shall be followed while selecting the women candidates by following the Judgment dated 18.07.2007 of the Hon'ble Supreme Court of India in the case of Rajesh Kumar Daria Vs. Rajasthan Public Service Commission and others (Civil Appeal No.3132 of 2007).
- d) The Government of Telangana reserves the right either to increase or decrease the number of vacancies after issuance of the Notification or may also cancel the Notification at any stage, if the situation warrants.

#### 6. SCHEME OF EXAMINATION, MINIMUM MARKS AND SYLLABUS:

- a) For the purpose of short listing the candidates, the High Court for the State of Telangana may, if necessary, hold a Screening Test comprising of multiple-choice objective type questions, and call upon the candidates who have secured 40% and above marks in the Screening Test, in the ratio of 1:10 of the available vacancies, for a written examination. If there are more than one candidate who have secured identical Qualifying marks in the screening test, all such candidates shall be called for the written examination.
- b) The marks obtained in the screening test shall not be added to the marks obtained in the written examination and they shall not be counted for determining final order of merit of the candidates, as the screening test is meant for short-listing the candidates.

#### 7. WRITTEN EXAMINATION:

- a) Written Examination consisting of the following three (3) papers will be held.
  - I. Constitution and Civil Laws,
  - II. Criminal Laws and
  - III. English (includes Translation from English to Telugu Language and Telugu to English Language, Essay Writing, Grammar and Vocabulary).

English paper is divided into two parts. Part-I carries 30 marks and Part-II carries 70 marks (40 marks for essay writing on legal subjects and 30 marks for grammar and vocabulary). In Part-I the candidate's ability to understand his/her proficiency in Telugu language will assessed. Candidate is required to translate from English to Telugu language and Telugu to English language. In Part-II, candidate's ability in Essay writing, Grammar and Vocabulary will be assessed. The Essay Writing test shall be on Legal subjects only. Candidate has to secure 50% marks in each part to qualify in the written examination.

- b) The Paper III (English) shall be considered only as a qualifying examination and the marks secured in the said Paper III shall not be included in calculating the aggregate for shortlisting the candidates for viva-voce test.
- c) **Each paper shall carry 100 marks.** The duration of each paper shall be three hours. The medium of examination shall be English.

### 8. MINIMUM MARKS TO BE SECURED IN THE WRITTEN EXAMINATION TO QUALIFY FOR VIVA VOCE:

- a) The candidate applying for being appointed under direct recruitment, who secures not less than 60% of marks in Papers I and II each in the written examination shall be eligible for *Viva Voce* carrying 30 marks.
- b) The candidates belongs to Scheduled Castes and Scheduled Tribes and persons with physically disability (40% and above) who secure not less than 50% marks in Papers I and II each in the written examination shall be eligible for the *Viva Voce* carrying 30 marks.
- c) From among the successful candidates, the High Court shall call the candidates for Viva-Voce in the ratio of 1:3 of the available vacancies.
- d) Further, if there are more than one candidate who have secured identical cut off marks, for maintaining the ratio of 1:3, all such candidates shall be called upon to appear for *Viva Voce*.
- e) The candidates belongs to Scheduled Castes and Scheduled Tribes and persons with physically disability (40% and above), who secure minimum 40% marks in the *Viva Voce* and all other candidates than those mentioned herein above who secure minimum 50% marks in the *Viva Voce* to be eligible for being recommended to Service.
- f) The provisional selection of the candidates is based on the aggregate marks obtained in written examination (only in paper (I) and paper (II)) and *Viva Voce*.

### 9. VIVA VOCE:

- a) Viva Voce shall carry 30 marks. Any candidate who remains absent for the Viva Voce shall be deemed to have been disqualified for selection.
- b) The object of the *Viva Voce* is to assess the suitability of the candidate for the cadre by judging the mental alertness, knowledge of law, clear and logical exposition, balance of judgment, skills, attitude, ethics, power of assimilation, power of communication, character and intellectual depth and the like, of the candidate.

c) In the selection process, the proficiency and knowledge of applicants will be tested in the following,

The applicants belonging to SC, ST and EWS categories have to pay Rs.500/- (Rupees five hundred only) towards examination fee. The applicants shall enclose photocopies of certificates attested by a Gazetted Officer in proof of the eligibility, and shall send the application to the Chief Secretary to Government of Telangana, General Administration Department, Telangana Secretariat, Hyderabad-500022, and they shall reach the Chief Secretary not later than 5.00 pm on 13.06.2024 with the cover super-scribed as "Application for appointment to the post of District Judge (Entry Level) in the Telangana State Judicial Service under Direct Recruitment-2024."
- b) Proforma application and other details will be available in the website of High Court for the State of Telangana, Hyderabad "tshc.gov.in".

- a) Incomplete applications and applications without enclosing certificates in proof of the particulars given in the applications and also the applications received after 5.00 pm on 13.06.2024 will be summarily rejected.
