The Prl. 3. The Individuals are directed to submit physical fitness certificate issued by the competent authority not below the rank of Civil Surgeon or District Medical & Health Officer along with their joining report and one set of Attested copies of their certificates.

4. The appointments of the above Individuals is purely on temporary basis and are liable to be terminated at any time without notice and without assigning any reason therefor or on administrative grounds.

5. The above Individuals are on probation for a total period of two years on duty within a continuous period of three years from the date of their joining in the post.

6. If the Individuals are employed in any post in the State/Central Government or in any organization or undertaking at present, they shall resign to that post and submit a copy of relieving order without fail.


7. In case, they are not employed in any pensionable post either in the State/Central Government or in any organization or undertaking, their appointments will be governed by the Contributory Pension Scheme (CPS) in terms of G.O.Ms.No.655, Fin (PEN-I) Department, dated 22/09/2004.

8. If the appointees does not join his/her post on or before 23/01/2024, it will be deemed to have been cancelled without any further notice.

9. The newly recruited staff are required to stay at their respective Headquarters and whenever they leave the Headquarters, they shall obtain prior permission of their respective officers.

10. The Superintendent/CMO of the concerned Courts are instructed to impart practical training to the newly recruited staff posted to their respective Courts.

11. Further, the Presiding Officers are requested to intimate the date of joining of the above individuals in their Courts.
