The Prl. 2. The seniority of the above candidate/s shall be fixed as per the instructions of the Hon'ble High Court vide reference 2<sup>nd</sup> cited, in terms of the decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others { (2003) 5 SCC 604 }

3. The Candidate/s are directed to shall submit physical fitness certificate issued by the competent authority not below the rank of Civil Surgeon or District Medical & Health Officer at the time of their joining report and one set of Attested copies by Gazetted Officer of their certificates along with Originals.

The Candidate/s are informed that their appointments are made purely on temporary basis and are liable to be terminated at any time without notice and without assigning any reason therefor or on administrative grounds and subject to the out come of any Writ Petitions pending before the Hon'ble High Court.

5. The above Candidate/s are on probation for a total period of two years on duty within a continuous period of three years from the date of their joining in the post.

6. If the Candidate/s are employed in any post in the State/Central Government or in any organization or undertaking at present, they shall resign to that post and shall submit a copy of relieving order without fail.

7. The Candidates appointed to the above posts are covered by the Contributory Pension Scheme (CPS). The Pension Scheme as per T.S. Revised Rules, 1980 is not applicable to them, as per in terms of G.O.Ms.No.766, Fin (PEN-I) Department, dated 22/09/2014.

**8. The Candidate/s are directed to shall join his/her post within two weeks/on or before 01/12/2023 without fail from the date of receipt of this order. If not join duty they appointment, it will be deemed to have been cancelled without any further notice.**

9. The newly recruited staff are shall stay at their respective Headquarters and whenever they leave the Headquarters, they shall obtain prior permission of their respective officers.

10. The Superintendent/CMO of the concerned Courts are instructed to impart practical training to the newly recruited staff posted to their respective Courts.

**11. The concerned Presiding Officers are requested to verify original testimonials of the newly recruited candidate/s and submit a set of Photostat copies to the District Court duly attested by the Gazetted Officer along with originals and also with intimate the date of joining of the above individuals in their Courts.**
