<b>Note</b>	1. This appointment orders are issued subject to the verification of the antecedents from the Concerned Police and if any adverse remarks are reported in the verification of the antecedents, their selection to the post shall be reviewed and a decision will be taken by the Hon'ble High Court in the matter.
	2. The candidates are informed that as they have submitted "Declaration" that the information furnished by them in the application is true, and they are not having higher qualification than 10 <sup>th</sup> class, in case of any information furnished by them found false or incorrect, in future their appointment to the post shall be terminated and they shall also be liable for criminal prosecution.
	3. The two (02) posts of Office Subordinate earmarked to OC (Blindness or Low vision)(W) (Roster Point No.6) and BC-C (Roster Point No.14) are unfilled due to non-availability of suitable candidates.

**N.B:**

1. The above mentioned candidates are hereby informed that their appointments are made purely on temporary basis and that it does not confer any right of probation or reappointment and that they will be ousted from service at any time without notice and without assigning any reason.

2. The above mentioned newly appointed Office Subordinates are hereby directed to report duty **on or before 22.01.2024** from the date of receipt of this orders, failing which they will forfeit all the rights over their appointments.
3. The candidates are directed to produce **Physical Fitness Certificates** issued by the medical Officer not below the rank of Civil Assistant Surgeon at the time of reporting duty.
4. The appointments of the above mentioned candidates as Office Subordinates are made in accordance to the provisions contained in section 4 of Act 2 of 1994 and all the service conditions applicable to Telangana Judicial Ministerial Service Rules are mutatis mnutandis applicable to the above individuals.
5. The above mentioned newly appointed candidates are covered by the CONTRIBUTORY PENSION SCHEME ONLY as per G.O. Ms No. 653, 654, 655 Finance (Pen-I) Department, dt. 22.09.2004 issued by the Government.
6. The above mentioned candidates are informed that if at all the documents produced by the candidates are found to have been created, manipulated, interpolated or forged in feature date, they would be removed/ dismissed from the service besides launching criminal persecution against them.
7. The pay of the above mentioned newly appointed Office Subordinates shall be fixed in the time scale of **Rs.19000-58850, under RPS-2020**, as per GO Ms No. 51, Finance (HRM.IV) Department, dated; 11.06.2021 issued by the Government .
8. The seniority of the above candidates has been fixed as per the instructions of the Hon'ble High Court vide reference 4<sup>th</sup> cited, in terms of the decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others { (2003) 5 SCC 604 }.
9. The Candidates in the proceedings who are now working in other departments are directed to submit relieving certificate from their employer and submit the same in the Prl. District Court, Jayashankar Bhupalpally before joining duty.
10. The above candidates shall be on probation for a total period of two years on duty within a continuous period of three years from the date of their joining in the post.
11. The Presiding Officers Concerned are requested to intimate the date of joining of the above Candidates to this Court.
