In view of provisional selection of the candidates by the Hon'ble High Court in the reference 2nd read above and in pursuance of the directions of the Hon'ble High Court in the reference 4th read above, the Principal District and Sessions Judge, Jayashankar Bhupalpally, is pleased to pass the following;

ORDER :

Rajitha Thatipamula, B.C.-B, (Hall Ticket No. TSHC23002179), D/o. Srinivas, H.No: 17-3-445/92, Nanamiya Thota, Kareemabad, Warangal District, who has been selected for the post of Stenographer Grade-III by the Hon'ble High Court at Roster Point No.1 (OC-W) of Cycle-I, is temporarily appointed as Stenographer Grade-III and posted in the Court of **Principal Junior Civil Judge-cum-JMFC, Jayashankar Bhupalpally** in the existing vacancy.

Note	1. This appointment orders are issued subject to the verification of the antecedents from the Concerned Police and if any adverse remarks are reported in the verification of the antecedents, their selection to the post shall be reviewed and a decision will be taken by the Hon'ble High Court in the matter.
	2. The One (01) post earmarked to SC (W) (Roster Point No.2) is unfilled due to non-availability of suitable candidate.

N.B:

1. The above mentioned candidate is hereby informed that her appointment is made purely on temporary basis and that it does not confer any right of probation or reappointment and that she will be ousted from service at any time without notice and without assigning any reason.

2. The above mentioned newly appointed Stenographer Grade-III is hereby directed to report duty **on or before 22.01.2024** from the date of receipt of this order, failing which she will forfeit all the rights over her appointment.

3. The candidate is directed to produce **Physical Fitness Certificates** issued by the medical Officer not below the rank of Civil Surgeon/District Medical & Health Officer at the time of reporting duty.
4. The appointment of the above mentioned candidate as Stenographer Grade-III are made in accordance to the provisions contained in section 4 of Act 2 of 1994 and all the service conditions applicable to Telangana Judicial Ministerial Service Rules are mutatis mutandis applicable to the above individual.
5. The above mentioned newly appointed candidate is covered by the CONTRIBUTORY PENSION SCHEME ONLY as per G.O. Ms No. 653, 654, 655 Finance (Pen-I) Department, dt. 22.09.2004 issued by the Government.
6. The above mentioned candidate is informed that if at all the documents produced by the candidate is found to have been created, manipulated, interpolated are forged in future date, she would be removed/ dismissed from the service besides launching criminal persecution against her.
7. The pay of the above mentioned newly appointed Stenographer Grade-III shall be fixed in the time scale of **Rs.32810-96890 under RPS-2020**, as per GO Ms No. 51, Finance (HRM.IV) Department, dated; 11.06.2021 issued by the Government .
8. The seniority of the above candidate has been fixed as per the instructions of the Hon'ble High Court vide reference 4th cited, in terms of the decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others { (2003) 5 SCC 604 }.
9. The Candidate in the proceeding who is now working in other department is directed to submit relieving certificate from her employer and submit the same in the Prl. District Court, Jayashankar Bhupalpally before joining duty.
10. The individual is hereby directed to shall stay at Headquarter and whenever leave the Headquarters, her shall obtain prior permission of respective Officer concerned.
11. The above candidate shall be on probation for a total period of two years on duty within a continuous period of three years from the date of their joining in the post.
12. The Presiding Officer Concerned is requested to intimate the date of joining of the above Candidate to this Court.
