Sealed quotations are invited from reputed Bidders/ Contractors/Agencies for "**the Sale/auction of old Teak Wood Materials** on "**As is where is basis**" and "**As is what is basis**" in the District Court, Buldana as per details given in **Annexure "B"**.

TERMS AND CONDITIONS

- 1) The last date for submission of quotation in the prescribed format is 03/02/2025 up to 5.00 p.m.
- 2) The Scrap material will be sold in **as is where is condition**. No Claim query/dispute will be entertained in this regard after submission of quotation.
- 3) The bidder shall quote the amount in Rupees for whole lot of old Teak Wood Materials as per the details mentioned at Annexure-"B", in the sealed quotation by indicating on the Envelope "Quotation for purchase of Old Teak Wood Materials".
- 4) The award of Auction/The items shall be sold to the bidder whose offer will be the affordable highest price.

- 5) The Bidder must not have been blacklisted by Central/State Government, Corporations or Government undertakings. Undertaking to that effect must be submitted by the bidder.
- 6) The old Scrap material is available for inspection on any working day between 10.00 a.m. to 5.00 p.m. before the last date of submission of quotations, in coordination with a responsible officer/official from the Cash & Finance Section, District Court, Buldana.
- 7) The prescribed form/Price Bid. for submitting the quotations is in **Annexure- "A"** and details of old teak wood materials to be auctioned in **Annexure "B"** which may be downloaded from website: **<https://buldana.dcourts.gov.in>**
- 8) All material will be auctioned in one lot to the successful bidder and no partial bid shall be entertained. If the quoted rate is less than the upset value provided by the Forest Department, it will not be accepted.
- 9) The bidders should submit a Tender Fee for Rs.500/- [non-refundable] and EMD for Rs.5,000/- by Demand Drafts of any Nationalized Bank drawn in favor of District Judge-1 & Additional Sessions Judge, Buldana, payable at State Bank of India, Main Branch Buldana with the quotation. The quotation without Tender Fee and EMD Shall be summarily rejected.
- 10) The EMD of the unsuccessful bidder will be returned and that of successful bidder shall be returned after the successful completion of the work. If the successful bidder fails to lift/carry the articles from this office within 03 days from the receipt of the work order, the amount of Rs.5000/-

shall be forfeited.

11) The interested bidders may submit the price bid duly signed and in a Sealed Envelope along with Demand Drafts and photocopies of relevant documents i.e. PAN Card and Annexure "C" with sign.

12) It shall be presumed that, the bidders have fully inspected the old/unused/Beyond repairable old teak wood materials before submitting their tenders. The District Court, Buldana shall not be responsible and shall not entertain any complaint in this regard after submission of quotation.

13) The items once sold to the successful bidder shall not be taken back on any condition whatsoever.

14) The successful bidder shall pay the entire amount so quoted, by Demand Draft within 24 hrs., from the receipt of work order in the office of the Principal District & Session Judge, Buldana and then proceed to lift the said old teak wood materials from this office at their own cost.

15) The office will issue work order in favor of successful bidder in respect of auction of Old teak wood materials.

16) The time limit for removal of the auctioned materials shall be 03 days from the date of receipt of work order. The successful bidder is required to lift the auctioned articles at his/her own cost within 03 days of receipt of communication from the office, during office hours after depositing the entire amount so quoted, by Demand Draft of any Nationalized Bank.

- 17) While carrying the articles, care shall be taken not to create nuisance in the premises of the District Court.
- 18) The bidder/contractor/agency shall be responsible for taking all necessary permissions from the competent authority of District Court, Buldana.
- 19) The material shall be lifted from the site by the successful bidder at its own cost.
- 20) Any damage caused by the workmen of the contractor to wall, ceilings, floors fixtures etc should be made good at the contractor's cost.
- 21) The undersigned reserves the right to adjourn or cancel or modify the terms of auction with or without notice and will not be responsible for any loss or inconvenience caused to anyone in this regard.
- 22) The decision of the District Court, Buldana in the qualification criteria and selection of bidder shall be final and binding on participated bidders. No correspondence will be entertained outside the process of negotiation / discussion with the District Court, Buldana.
- Note : District Court, Buldana reserves the right to waive any minor informality or non-conformity or irregularity in the tender.
- 23) The District Court, Buldana reserves the right to accept or reject any quotation, cancel the tendering process at any stage, split orders and to annul the Bidding process and reject all Bids at any time, without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the grounds for Tendering Authority's action.


**24) Arbitration :-** In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and / or in relation to the implementation or interpretation thereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the sole arbitrator appointed by Buldana District Court. The arbitration shall be at Buldana and the Arbitrator shall give his award in accordance with "The Arbitration and Conciliation Act, 1996". The decision of the arbitrator shall be final and binding upon the parties.

**25) Legal Jurisdiction :-**

Legal dispute if any, shall be subject to the jurisdiction of Buldana in Maharashtra only.
