### NOTIFICATION

Sub: COURTS – CRIMINAL – SPL. JUDICIAL SECOND CLASS MAGISTRATES' COURTS – Notification issued calling for applications from the eligible candidates for 'filling up of the post of Spl. Judicial Magistrate of Second Class for Railways, Kazipet – Regarding.

Notification is hereby issued calling for applications for filling up of the post of Special Judicial Magistrate of Second Class for Railways, Kazipet, from the eligible candidates fulfilling the eligibility criteria for the post of Special Judicial Magistrate of Second Class and guidelines mentioned together with full bio-data of the candidates, in duplicate:

The applications of eligible aspirants, along with all necessary documents, duly attested by a Gazatted Officer, in duplicate, should reach directly to this Office on or before / 3 /09/2023 by 5.00 p.m. Applications received after the above date, will be rejected and shall not be considered under any circumstances.

**ELIGIBILITY CRITERIA:** Possessing a Law Degree, Legal and Magisterial Experience.

#### QUALIFICATIONS:-

#### A Person

- i) Who has held any post in Higher Judicial Service or State Judicial Service and retired or resigned or
- ii) Who has held a post in the Judicial Ministerial Service not below the rank of Superintendent (Category-III), and has a <u>Law Degree</u>, or
- iii) Who has held a post of Section Officer and above in the High Court Service and has <u>Law Degree</u>, or

- iv) A non-practicing Advocate with a practice at the Bar of not less than five years and who is above 45 years of age (must file a certificate of voluntary suspension of practice issued by the Bar Council of Andhra Pradesh or Telangana) or
- v) Any retired Gazetted Officer possessing Law Degree or who has passed the Criminal Judicial Test (Full test consisting of Criminal Procedure) conducted by the Telangana Public Service Commission and who has exercised Magisterial Powers during his/her tenure of service for not less than three years.
- vi) And who has, at least, one year to complete 65 years of age i.e. as on 01/07/2023.

## **DISQUALIFICATIONS:-**

#### A person

- 1. Who is a practicing Advocate, or
- 2. Who is a member of any State or Local authority, or
- 3. Who is a member of the State Legislature or Parliament, or
- 4. A person who having held an office under the State or the Union Government or any Local Authority, has been dismissed or removed or compulsorily retired from service or subjected to any other major penalty for misconduct, or
- 5. A person who has been convicted and sentenced by a Court for an offence involving moral delinquency or is charged of any offence constituting moral turpitude and proceedings are pending, or
- 6. A person of unsound mind or who is deaf or mute or blind or suffering ffrom any contagious disease, or
- 7. A person adjudicated as insolvent or an undercharged insolvent, or
- 8. A contract or a business man or one interested in a subsisting contract or any work being done for Central or State Government or a Local Authority within whose limits the Special Magistrate has to discharge his duties, shall not be eligible.

## REVOCATION OF POWERS OF SPECIAL MAGISTRATES:-

- 1. On appointment and while in service a Special Judicial Magistrate of Second Class or Special Magistrate of any other category may be removed without being called upon to show cause if he/she fails to attend three consecutive sittings of the Court without a written permission of the Chief Judicial Magistrate, Hanumakonda.
- 2. Powers conferred by the Court on Special Judicial Magistrate of Second Class shall automatically stand withdrawn on his/her attaining the age of 65 years.

## **GENERAL INSTRUCTIONS:-**

- 1. As per the Hon'ble High Court's circular in ROC No. 802/SO/97, dated 29.01.1998 the Special Judicial Second Class Magistrates' Courts are functioning for (5) days in a week, i.e., from Monday to Friday on working days between 7.30 AM and 10.30 AM.
- 2. The appointing authority reserves the right to cancel the notification without assigning any reason thereof.
- 3. No T.A will be paid for candidate for journey performed in connection with recruitment.
- 4. Applications of candidates which do not contain all the necessary copies of documents, such as qualification certificates, retirement proceedings, etc., will be rejected.
- 5. Applications with insufficient information will be summarily rejected.
- 6. The applications submitted in a sealed cover with super scribing the name of the post on the cover.
- 7. Applications will not be received by hand from the individuals.

Provided that a suitable retired Judicial Officer shall be preferred.
