In view of provisional selection of the candidates by the Hon'ble Telangana State Legal Services Authority, Hyderabad, reference 2nd read above, the Principal District Judge-cum-Chairman, District Legal Services Authority, Hanumakonda, is pleased to pass the following

ORDER:

1. Ms. Villandula Swapna, (Hall Ticket No. 24040025) D/o. Shiva Prasad, R/o. H.No. 16-4-856, Shiva Nagar, Warangal, who has been selected for the post of Steno/Typist by the Hon'ble Telangana State Legal Services Authority, Hyderabad at Roster Point No.1 (General) of Cycle-1, is temporarily appointed as Steno/Typist and posted in District Legal Services Authority, Hanumakonda of Hanumakonda District in the existing vacancy.

- 1. The above mentioned candidate is hereby informed that her appointment is made purely on temporary basis and that it does not confer any right of probation or reappointment and that she will be ousted from service at any time without notice and without assigning any reason.
- 2. The individual is hereby directed to report duty within in (/s) days from the date of receipt of this orders, failing which she will forfeit all the rights over the appointment.
- 3. The candidate is directed to produce <u>Physical Fitness Certificates</u> issued by the medical Officer not below the rank of Civil Assistant Surgeon at the time of reporting duty.
- 4. The appointment of the above mentioned candidate is made in accordance to the provisions contained in Section 4 of the Telangana (Regulation of Appointment to Public Services and Rationalization of Staff Pattern and Pay Structure), Act, 1994.

- 6. The above mentioned candidate is informed that if at all the documents produced by her are found to have been created, manipulated, interpolated are forged in feature date, she would be removed/ dismissed from the service besides launching criminal persecution against her.

- 8. The Candidate in the proceedings who is now working in other department if any, is directed to submit relieving certificate from the employer and submit the same before joining duty.
- 9. The above candidate shall be on probation for a total period of two years on duty within a continuous period of three years from the date of joining in the post.
