The Hon'ble High Court, Madras has given instructions to the District Judiciary to mandatory e-Filing of cases to the Courts dealing with the cases arising under Sec.138 of Negotiable Instrument (NI) Act and to the Courts dealing with Criminal Appeals and Criminal Revisions and allied matters arising in Cheque Bounce cases in the District Judiciary as per the 1st reference cited above.

Further it is informed, all Appeals, Revisions, all the Original Petitions (OP) and Motor Accident Claims Original petitions (MCOP) are already mandated through e-Filing mode in Tiruppur District as per the 2nd reference cited above.

Hence, all the Judicial Officers in this district are hereby required to instruct the staff members concerned in e-filing section to <u>mandated the e-filing facilities to the</u> <u>Courts dealing with the cases arising under Sec.138 of Negotiable Instrument (NI)</u> <u>Act and allied matters arising in Cheque Bounce cases</u> filed by the Advocates / Litigants.

Further it is informed that the above said category of cases must be taken on file only through E-filing mode with immediate effect. The physical mode of filing for the above said category of cases are dispensed herewith. Therefore, The Advocates/ Litigants are requested to file the above said category of cases only through E-filing mode.

Further it is informed that the account creation process shall be verified by One Time Password (OTP) which will be sent to the Mobile Number and email address of the concerned Advocate/Party-in-person. A detailed guidelines and tutorial video

prepared by the Hon'ble Madras High Court for the e-filing process and the detailed user manual prepared by the Hon'ble e-Committee, Supreme Court of India is available on the website of Madras High Court (<u>https://www.hcmadras.tn.nic.in/efiling.html</u>)

It is further informed that to create an account in e-filing portal, Advocates are required to register their details such as Bar Enrollment Number, Mobile Number, e-mail ID etc., in the CIS Software Application by submitting the duly filled application form to the email address "<u>tpr.pdc-tn@indiancourts.gov.in</u>". (Form is also enclosed with this notification).

It is also informed that the <u>Advocates who have already registered their details in</u> <u>CIS Server (While Centralized Filling) need not submit the application form again.</u>

Further, the Advocates are required to avail the e-filing facility, using their own equipment.
