- ❖ Private Complaints made before Judicial Magistrate and Criminal Revision thereon and to all the cases filed by Banks and Financial Institutions
- ❖ Matrimonial Cases
- ❖ Cases under Domestic Violence Act and to the Cases filed under Sec.125 to 128 of Criminal Procedure Code, 1973
- ❖ Commercial cases and to their Appeals
- ❖ Intellectual Property Cases and Arbitration matters in the District Judiciary as per the references cited mentioned above.

Further it is informed, all Appeals, Revisions, all the Original Petitions (OP) and Motor Accident Claims Original petitions (MCOP) are already mandated through e-Filing mode in Tiruppur District as per the 1<sup>st</sup> reference cited above. The earlier circular issued in this regard may kindly be referred.

**Further it is informed that the above said category of cases would be taken on file only on the cases being filed through E-filing mode in the required format with effect from 01.09.2023. The physical mode of filing for the above said category of cases would not be accepted.** Therefore, The Advocates/Litigants are requested to file the above said category of cases only through E-filing mode.

Advocate/Party-in-person are requested to follow the “**Madras High Court e-Filing Rules 2020**”, notified in the Official Gazette and available in the website of Madras High Court (<http://www.hcmadras.tn.nic.in>) and District Court Tiruppur (<https://districts.ecourts.gov.in/tiruppur>) for kind reference.

In case of any difficulty in registration or e-Filing of cases, the Advocates / Party-in-person may seek the assistance of the officials between 10.30 a.m to 3.00 p.m on all working days.
