- ❖ The candidates are hereby instructed to bring the written arguments or any legal pleadings which they have filed in the criminal courts with regard to necessary case numbers.
- ❖ No individual interview call letter will be sent by post to any candidate whose name found in the provisional list and the candidate(s) shall have to download the provisional list for confirmation <https://districts.ecourts.gov.in/tiruppur> website and appear before the interview committee on the scheduled date, time and venue.
- ❖ Candidates must bring photocopy of Aadhaar Card / Driving License / Voter ID.
- ❖ Possession of electronic devices such as Cell phone, smart watches and all forms of Bluetooth devices are strictly prohibited into the interview hall.
- ❖ Failure of any candidate to appear for the interview on the given date and time shall forfeit his/her right of consideration.
- ❖ In case of any discrepancy with reference to eligibility etc., is found at the time of interview, the applicant concerned shall not be allowed to appear in the interview, and if any discrepancy is found, subsequently, the candidate concerned shall not be considered for selection and he/she be treated as disqualified.
- ❖ The candidates shall have to produce all original certificate/testimonials before the selection committee at the time of interview. A candidate who fails to produce such certificates/testimonials may forfeit his/her candidature.
