

1. The Principal District and Sessions Judge, Jalna is pleased to modify the above referred order and to pass following order with effect from 01/11/2023.
2. The allotment of all Criminal Bail Applications U/s. 439 of Cr.P.C. i.e. Regular Bail Applications and all Criminal Bail Applications U/s. 438 of Cr.P.C. i.e. Anticipatory Bail Applications except MCOCA Act, Atrocities on Women and P.O.C.S.O. Act., Prevention of Corruption Act, Schedule Caste and Schedule Tribes (Prevention of Atrocities Act 1989) in the District and Sessions Court, Jalna shall be made over to the file of the Adhoc District Judge-1 & Additional Sessions Judge, Jalna.
3. The allotment of MCOCA Act Bail Applications U/s. 439 of Cr.P.C. i.e. Regular Bail Applications and Bail Applications U/s. 438 of Cr.P.C. i.e. Anticipatory Bail Applications in the District and Sessions Court, Jalna shall be made over to the file of the District Judge-1 & Additional Sessions Judge, Jalna.
4. The allotment of Atrocities on Women and POCSO Act Bail Applications U/s. 439 of Cr.P.C. i.e. Regular Bail Applications and Atrocities on Women and POCSO Act Bail Applications U/s. 438 of Cr.P.C. i.e. Anticipatory Bail Applications in the District and Sessions Court, Jalna shall be made over to the file of the District Judge-2 & Additional Sessions Judge, Jalna.
5. The allotment of Prevention of Corruption Act Bail Applications U/s. 439 of Cr.P.C. i.e. Regular Bail Applications and Bail Applications U/s. 438 of Cr.P.C. i.e. Anticipatory Bail Applications in the District and Sessions Court, Jalna shall be made over to the file of the District Judge-3 & Additional Sessions Judge, Jalna.
6. The allotment of Schedule Caste and Schedule Tribes (Prevention of Atrocities Act 1989) Bail Applications U/s. 439 of Cr.P.C. i.e. Regular Bail Applications and Bail Applications U/s. 438 of Cr.P.C. i.e. Anticipatory Bail Applications in the District and Sessions Court, Jalna shall be made over to the file of the District Judge-4 & Additional Sessions Judge, Jalna.
7. Subsequently filed Bail Applications U/s. 438 and 439 of Cr.P.C. be made over to the Court by which the 1st Bail Application U/s. 438 and 439 of Cr.P.C. was disposed of. If more than one bail applications are filed by the co-accused persons arising from the same FIR, should be made over to the same Court to avoid any disparity in passing of the orders in the bail applications.

8. Bail applications of accused in pending Sessions/Special case be allotted to the Concerned Court where Sessions/Special case of said accused is pending.


