In obedience to the directions of the Hon'ble High Court vide reference 2<sup>nd</sup> cited, the Principal District and Sessions Judge, Bhadradi Kothagudem is pleased to pass the following appointment orders:

**Miss Degala Samrajyam** is selected for the post of **Junior Assistant** under Direct Recruitment, under Telangana Judicial Ministerial and Subordinate Service Rules and the individual is temporarily appointed as Junior Assistant in the time **scale of 24280- 72850 (PRC-2020)** in the Roster Point and Cycle noted against her name and posted as Junior Assistant in the court mentioned against her name.

The Seniority of the candidate is fixed as per their merit by following the decision of Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others [ (2003) 5 SCC 604 ].

All the service conditions applicable to Telangana Judicial Ministerial Service Rules are mutatis mutandis applicable to the above individual.


The above candidate appointed after 01.09.2004, as such they will be covered by the Contributory Pension Scheme.

**Note:**

1. The individual is directed to report for duty before the Court concerned within one month from the date of dispatch of this order, failing which the offer of appointment shall be treated as automatically canceled.
2. The individual is directed to submit Physical Fitness Certificate issued by not below the rank of Civil Surgeon or a District Medical officer, along with her joining report.
3. The individual is directed to execute an agreement bond that she shall serve the Department for a period of three years, if she fails to do so, for any reason, (or) if she secures any other employment elsewhere than under the State Government, shall be liable to refund to the Government the pay and allowances or any other remuneration received by her until then.
4. The individual shall deposit security in the sum of Rs.10,000/- for the due and faithful performance of duties attached thereto, in the form of FDR.
5. The individual is directed to produce one set of true copies of educational qualifications, study and caste certificates duly attested by the Gazetted Officer.



6. The Officer concerned is instructed to inform the date of joining of the above individual along with a copy of Physical Fitness Certificate.
