In obedience to the directions of the Hon'ble High Court vide reference 2<sup>nd</sup> cited, the Principal District and Sessions Judge, Bhadradi Kothagudem is pleased to pass the following appointment orders:

**Smt. BOPPANI NAVYA** is selected for the post of **Process Server** under Direct Recruitment, under Telangana Judicial Ministerial and Subordinate Service Rules and the individual is temporarily appointed as Process Server in the time scale of **22,900-69150 (PRC-2020)** in the Roster Point and Cycle noted against her name and posted as Process Server in the court mentioned against her name.

The Seniority of the candidate is fixed as per their merit by following the decision of Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others [ (2003) 5 SCC 604 ]. The Character and antecedents of the candidate have been got verified by the Police and found no adverse remarks.

3. The individual shall deposit security in the sum of Rs.10,000/- for the due and faithful performance of duties attached thereto, in the form of FDR.
4. The individual is directed to produce one set of true copies of educational qualifications, study and caste certificates duly attested by the Gazetted Officer.
