5. The individuals are appointed to the posts of Process Server shall, for the due and faithful performance of duties attached thereto, deposit an amount of Rs.10,000/- (Rupees ten thousand only) towards security at the time of joining report.
6. The individuals shall abide by the Conduct and other Service Rules.
7. The individuals are informed that, they will be governed by the contributory pension scheme as per G.O.Ms.Nos.653, 654 & 655, Finance (Pension-I) Dept., dt. 22.09.2004 and the pension scheme under A.P. Revised Pension Rules, 1980 not applicable to them.
8. The seniority of candidates is fixed as per their merit in view of decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others (2003) 5 SCC 604.
9. The individuals will be on probation for a total period of two years on duty within a continuous period of three years as per Rule 13(a) of TJMSS Rules 2018.
