The Principal District and Sessions Judge, Nagarkurnool is pleased to pass the following orders :-

After perusing the confidential reports concerned and considering the Seniority -cum-Merit, the following candidates working in the cadre of Examiners (Cat.11)/Process Server (Cat.16) are hereby temporarily selected and promoted as Junior Assistants (Cat.08) as per TJM&SS Rules, 2018.

1. Ms P.Tejaswi, Examiner (Cat.11),(SC), I-Additional Junior Civil Judge Court, Kollapur is temporarily promoted as Junior Assistant (Cat.08) of TJM&SS Rules, 2018 and posted to work in the Court of I-Additional Junior Civil Judge, Kollapur in the existing vacancy.
2. Ms D.Vinod Kumar, Examiner (Cat.11),(BC-D), Principal District and Sessions Judge Court, Nagarkurnool is temporarily promoted as Junior Assistant (Cat.08) of TJM&SS Rules, 2018 and posted to work in the Court of the Principal Junior Civil Judge Court, Kollapur in the existing vacancy.
3. Sri K.Srinivasulu, Process Server (Cat.16), (BC-D), Principal District and Sessions Judge Court, Nagarkurnool, presently working on deputation in Fast Track Special Court for Expeditious Trial and Disposal of Rape and POC SO Act Cases, Nagarkurnool is temporarily promoted as Junior Assistant (Cat.08) of TJM&SS Rules, 2018 and posted to work in the Court of Principal District and Sessions Judge, Nagarkurnool in the existing vacancy until further orders.

Note:-

1. The above individuals are hereby informed that they are promoted purely on temporary basis and are liable to reverted at any time without assigning any reason.

2. The individuals will be on probation for a total period of one year on duty within a continuous period of two years as per Rule 13(b) of TJMSS Rules 2018.
3. The individual shall, for the due and faithful performance of the duties attached thereto, deposit a sum of Rs.10,000/- (Rupees Ten thousand only) in the form of fixed deposit drawn in their favour towards security within a month from the date of joining duty in the promotion post in their respective Courts. Noncompliance is subject to Rule 22(c) of TJMSS Rules, 2018.
4. The individual at Sl.No.01 is promoted as Junior Assistant (Cat.08) on condition that the individual is on observation for 06 months and the Presiding Officer concerned should observe the work performance and behaviour of the individual and send the monthly report to the Undersigned.
5. The individual at Sl.No.02 is promoted as Junior Assistant (Cat.08) on condition that he shall acquire "Graduation qualification" within (5) years from the date of issuance of these proceedings, failing which, he shall be reverted, without any prior notice.
6. **Though the individuals are promoted to the higher post, they are directed to do whatever work entrusted to them by the Presiding Officer concerned.**
7. All the above individuals are directed to hand over full charge of their respective seats (including updating of all relevant registers) to their successors as directed by their Presiding Officer leaving no pending arrears of work. The Presiding Officers concerned are also directed to relieve the individuals only after completely handing over the charge to their successors and further a copy of the charge list shall be sent to the undersigned within a week from the date of relieving the individual. The Presiding Officer shall also take a separate undertaking from the individual concerned mentioning that there are no arrears of work in his/her seat for being relieved from his/her post.
8. **The individuals are directed to report before their new stations/posts immediately after compliance of handing over full charge to their successors as mentioned in Sl.No.07 referred to above.**
9. The date of relieving and joining shall be intimated by the Presiding Officers concerned to the Undersigned.
