The Principal District and Sessions Judge, Nagarkurnool is pleased to issue the following orders :-

After perusing the confidential reports concerned and considering the Seniority -cum- Merit as per the combined seniority of the cadres of Junior Assistants(Cat.08), Typists(Cat.09) and the cadre of Field Assistants(Cat.10), the following candidates working in the cadre of Junior Assistants(Cat.08)/ Typist(Cat.09) / Field Assistant(Cat.10) are hereby temporarily selected and promoted as Senior Assistant (Cat.07) as per TJM&SS Rules, 2018.

1. Sri C.Chandra Shekar, Junior Assistant (Cat.08),(SC), Senior Civil Judge Court, Kalwakurthy is temporarily promoted as Senior Assistant (Cat.07) of TJM&SS Rules, 2018 and posted to work in the Court of I-Additional Junior Civil Judge (Mobile Court), Nagarkurnool in the existing vacancy and further the individual is deputed to work in the Court of Senior Civil Judge, Kalwakurthy until further orders.
2. Smt A.Anuradha, Typist (Cat.09),(SC), Senior Civil Judge Court, Nagarkurnool, presently working on deputation in the Court of I-Additional Junior Civil Judge (Mobile Court), Nagarkurnool is temporarily promoted as Senior Assistant (Cat.07) of TJM&SS Rules, 2018 and posted to work in the Court of Principal Junior Civil Judge, Nagarkurnool in the existing vacancy.
3. Sri M.Sathyanyaravana, Junior Assistant (Cat.08),(BC-A), I-Additional Junior Civil Judge Court, Kollapur is temporarily promoted as Senior Assistant (Cat.07) of TJM&SS Rules, 2018 and posted to work in the Court of Senior Civil Judge, Kalwakurthy in the existing vacancy and further deputed to work in the Court of I-Additional Junior Civil Judge Court, Kollapur.
4. Sri G.Vinod Kumar Reddy, Field Assistant (Cat.10),(OC), Principal District and Sessions Judge Court, Nagarkurnool, presently working on deputation in Fast Track Special Court for Expeditious Trial and Disposal of Rape and POCSO Act Cases, Nagarkurnool is temporarily promoted as Senior Assistant (Cat.07) of TJM&SS Rules, 2018 and posted to work in the Court of Senior Civil Judge, Nagarkurnool in the existing vacancy and further deputed to work in the Court of Fast Track Special Court for Expeditious Trial and Disposal of Rape and POCSO Act Cases, Nagarkurnool.

5. Sri MD.Asif Pasha, Junior Assistant (Cat.08),(OC), Junior Civil Judge Court, Achampet, is temporarily promoted as Senior Assistant (Cat.07) of TJM&SS Rules, 2018 and posted to work in the Court of Junior Civil Judge, Kalwakurthy in the existing vacancy and further deputed to work in the Court of Junior Civil Judge, Achampet until further orders.
6. Sri Beesam Naveen, Junior Assistant (Cat.08), (SC), Principal District and Sessions Judge Court, Nagarkurnool is temporarily promoted as Senior Assistant (Cat.07) of TJM&SS Rules, 2018 and posted to work in the Court of Principal District and Sessions Judge, Nagarkurnool in the existing vacancy.

Note:-

1. The above individuals are hereby informed that they are promoted purely on temporary basis and are liable to reverted at any time without assigning any reason.
2. The individuals will be on probation for a total period of one year on duty within a continuous period of two years as per Rule 13(b) of TJMSS Rules 2018.
3. The individuals shall, for the due and faithful performance of the duties attached thereto, deposit a sum of Rs.10,000/- (Rupees Ten thousand only) in the form of fixed deposit drawn in their favour towards security within a month from the date of joining duty in the promotion post in their respective Courts. Noncompliance is subject to Rule 22(c) of TJMSS Rules, 2018.
4. The individuals at Sl.No.01 and 02 are promoted as Senior Assistant (Cat.07) on condition that they shall acquire "Graduation qualification" within (5) years from the date of issuance of these proceedings, failing which, they shall be reverted, without any prior notice.
5. **Though the individuals are promoted to the higher post, they are directed to do whatever work entrusted to them by the Presiding Officer concerned until further orders.**
6. All the above individuals are directed to hand over full charge of their respective seats (including updating of all relevant registers) to their successors as directed by their Presiding Officer leaving no pending arrears of work. The Presiding Officers concerned are also directed to relieve the individuals only after completely handing over the charge to their successors and further a copy of the charge list shall be sent to the undersigned within a week from the date of relieving the individual. The Presiding Officer shall also take a separate undertaking from the individual concerned mentioning that there are no arrears of work in his/her seat for being relieved from his/her post.
7. **The individuals are directed to report before their new stations/posts immediately after compliance of handing over full charge to their successors as mentioned in Sl.No.06 referred to above.**
8. The date of relieving and joining shall be intimated by the Presiding Officers concerned to the Undersigned.
