#### Note:-

- 1. These orders will come into force with immediate effect.
- **2.** The candidates are informed that, they are appointed purely on temporary basis and their services are liable to be terminated at any point of time without notice and assigning any reasons.
- **3.** The candidates are directed to join duty within a prescribed period under Rule 11 of Telangana State and Subordinate Service Rules, 1996 if they are not join the post within the stipulated period their appointment shall be treated as automatically cancelled.
- **4.** The candidates are further informed that their appointments are made pending verification of their antecedents by the concerned police. As such in antecedents reports to be received from the Police concerned in due course, if any adverse remarks are reported against the candidates as to their antecedents and character, their appointments to the post shall be reviewed and a decision will be taken by the Hon's ble High Court for the State of Telangana.
- **5.** The candidates are directed to submit Physical Fitness Certificate while joining duty issued by a Medical Officer, not below the rank of a Civil Surgeon or a District Medical Officer and the Identity Proof.
- 6. The candidates shall abide by the Conduct and other Service Rules.
- 7. The individual is appointed to the post of Copyist shall, for the due and faithful performance of duties attached to him to deposit an amount of Rs.10,000/- (Rupees ten thousand only) towards security at the time of joining report.
- **8.** The candidates are informed that, they will be governed by the contributory pension scheme as per G.O.Ms.Nos.653, 654 & 655, Finance (Pension-I) Dept., dt. 22.09.2004 and the pension scheme under A.P. Revised Pension Rules, 1980 not applicable to them.
- **9.** The seniority of candidates is fixed as per their merit in view of decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others (2003) 5 SCC 604.
- 10. The candidates will be on probation for a total period of two years on duty within a continuous period of three years as per Rule 13(a) of TJMSS Rules 2018.
