In case of absence of officers mentioned in column No.3 and 5, the officers mentioned in column No.4 and 6 are hereby nominated for recording Dying Declarations. All the officers are hereby directed not to apply for any kind of leave during the period in which they are nominated to record Dying Declaration and in case of unavoidable circumstances only, they may apply for leave duly explaining the circumstances in detail in writing at least (3) days in advance by obtaining the consent of the other Presiding Officer who is willing to attend the duty of recording Dying Declarations and shall not leave the Head Quarters before the leave is granted. These orders shall come into force w.e.f. 28.02.2024. The receipt of the above proceedings shall be acknowledged.

Therefore, all the above mentioned Judicial First Class Magistrates are directed to attend the duties as per the above made arrangements, **until 31.12.2024.**

Further, the police authorities are directed to file the requisitions before the courts concerned, as per the above arrangements made by the undersigned.
