Further she is deputed to work in Principal Junior Civil Judge -cum- Judicial Magistrate of First Class, Kollapur until further orders.


Note:-

The above individuals shall report for duty before the Presiding Officer concerned within seven (7) days on receipt of the order, failing which the appointment would be deemed to have been cancelled and no further correspondence will be entertained. The period of contract of the above individuals shall come into force from the date of joining in the post to till the actual need ceases or attaining the age of 65 years, whichever is earlier.

The above persons appointed in Fast Track Special Court (FTC) for Expeditious Trial and Disposal of Rape and POCSO Act cases in the unit of Nagarkurnool District on contract basis shall be paid remuneration as fixed by the Government from time to time vide reference 3rd and 4th cited above.

The above individuals are required to submit a Physical Fitness Certificate issued by a Medical Officer not below the rank of an Assistant Civil Surgeon at the time of reporting for duty and shall enter into a contract agreement in the proforma prescribed for submission to the Hon'ble High Court. The persons appointed shall be purely on contract basis as per Rule 9 of Telangana State and Subordinate Service Rules, read with standing

orders of the Hon'ble High Court issued from time to time and they shall not be regarded as a member of service and shall not be entitled for preferential right to any other appointment and liable to be terminated at any point of time without any notice.
