- **4.** They are directed to submit Physical Fitness Certificate while joining duty issued by a a Medical Officer, not below the rank of a Civil Surgeon or a District Medical Officer and the Identity Proof
- 5. The individuals are appointed to the posts of Junior Assistant shall, for the due and faithful performance of duties attached thereto, deposit an amount of Rs.10,000/-(Rupees ten thousand only) towards security at the time of joining report.
- 6. The individuals shall abide by the Conduct and other Service Rules.
- 7. The individuals are informed that, they will be governed by the contributory pension scheme as per G.O.Ms.Nos.653, 654 & 655, Finance (Pension-I) Dept., dt. 22.09.2004 and the pension scheme under A.P. Revised Pension Rules, 1980 not applicable to them.
