The Presiding Officers concerned are also directed to relieve the individuals only after completely handing over the charge to their successors and further a copy of the charge list shall be sent to the undersigned within a week from the date of relieving of the individuals. The Presiding Officers shall also take a separate undertaking from the individuals concerned mentioning that there are no arrears of work in his/her seat for being relieved from his/her post.
