

PRINCIPAL DISTRICT AND SESSIONS COURT, NAGARKURNOOL

Applications are invited from the eligible candidates up to 5-00p.m on 11.02.2026 in the format enclosed herewith for appointment to the posts of Court Assistant (01) and Court Attendants (02) to work in the Courts of Special Judicial Magistrate of Second Class at Kollapur, Nagarkurnool of Nagarkurnool District Unit.

The Applications shall be submitted through Registered post or through Courier to "**The Principal District and Sessions Judge, Nagarkurnool**", and the application forms will not be entertained either directly or in person.

The **term of the post** of Court Assistant and Court Attendant is **(02) years** and shall be paid remuneration of Rs.5000/- for Court Assistants and Rs.3000/- for Court Attendants per Month.

I. ELIGIBILITY:

- Any retired person, who has not exceeded 64 years of age as on 01.07.2026 and who has held any post in the Telangana Judicial Ministerial and Subordinate Service or any retired person who held the post of Assistant, Examiner, Typist, Copyist and above in the T.S. High Court Service is eligible for appointment as Court Assistant.
- Provided that, if suitable retired employee from Telangana Judicial Ministerial and Subordinate Service and High Court Service is not available, an outsider can be appointed, if he/she posses the following qualifications:
 - Must have passed Graduation or any equivalent examination for the post of **Court Assistant**.
 - Must have passed **7th class** examination for the post of **Court Attendant**.
- Preference will be given to the local candidates i.e., persons who are living in the same station or near about place.

II. AGE:

- As on 01.07.2026 the candidates must not have completed (34) years and must have completed (18) years. The relaxation of maximum age limit is 5 years in respect of SC/ST & BC candidates and 10 years in respect of physically handicapped and Ex-Service Men.
- Any retired employee who crossed the age limit of 65 years shall not be eligible for the appointment of Court Assistant and Court Attendant.

III. SELF ATTESTED COPIES OF THE DOCUMENTS TO BE ENCLOSED TO THE APPLICATION:

- i. Certificates of Academic qualification.
- ii. Certificate evidencing date of birth.
- iii. One recent passport size photograph of the applicant is to be affixed at the top of the application in the place specified
- iv. Retired employees are to produce retirement proceedings.

IV. GENERAL INSTRUCTIONS:

1. Application to be submitted in the enclosed proforma and applications received in any other format will be summarily rejected.
2. The appointment to the above posts is purely on temporary basis, on payment of monthly honorarium i.e., Rs. 5,000/- to the Court Assistant and Rs. 3,000/- to the post of Court Attendant for a period of two years and the outsiders appointed for the said post do not confer any right for future employment on regular basis.
3. In the event of more than 20 candidates applying for each vacancy such applications will be short listed on the basis of marks obtained in the qualifying examination and the candidates who are considered most suitable for appointment will be called.
4. No. T.A. will be paid for candidate for journey performed in connection with recruitment.
5. Applications with insufficient information will be summarily rejected.
6. Applications, which do not contain necessary enclosures as detailed above will be rejected.
7. Applications received after 5.00p.m. on the date prescribed above will not be considered.
8. The office is not responsible for any postal delay, delay caused by any other service like courier or delay in delivery etc., and no correspondence will be entertain in any respect.
9. Candidate resorting to bring any influence of any kind will be summarily disqualified.
10. The appointing Authority reserves the right to cancel the notification without assigning any reason thereof.
11. As per the Hon'ble High Court Circular ROC.No. 802/S0/97, dt, 29.01.1998 the Spl. Judl. Magistrate of Second Class Courts are Functioning for (05) days in a week ie from Monday to Friday on working days between 7.30 a.m. and 10.30 a.m.

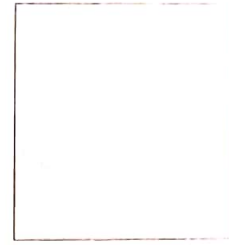
