

Note:

1. These orders will come into force with immediate effect.
2. The individuals are directed to report to duty on or before **dt. 06 .04 .2026** and shall attend the duties entrusted by the officer.
3. The appointment of individuals is purely on temporary basis and the individuals are appointed on part time contract basis for a period of two (2) years from the date of joining in the post.
4. The individuals are directed to enter into an agreement/contract with the District court from date of joining to till the need for existence ceases as per the orders of the undersigned.
5. The date of joining of the individuals should be reported to this court.
6. The individuals are eligible for fixed remuneration of Rs.5000/- per month for the posts of Court Assistant and Rs.3,000/- per month for the post of Court Attendant.
7. The District Judge, Nagarkurnool is competent to terminate the services of the individuals at any time, if the work is not satisfactory or on the ground of misconduct or negligence.
