The above candidates will be appointed on ad-hoc basis subject to condition that, they will have to pass the requisite test mentioned against their names within a period of one year from the date of their appointment.

The above candidates at Sr.No. 1, 4, 7 and 12 will have to the pass the English Shorthand Test within a period of one year from the date of appointment.

The above candidates at Sr.No. 2, 3, 6 and 10 will have to the pass the Marathi Shorthand Test within a period of one year from the date of appointment.

The above candidates at Sr.No. 5, 8, 9, 11, 13, 14, 15, 16 and 17 will have to pass the both English Shorthand Test and Marathi Shorthand Test within a period of one year from the date of appointment.

The above candidates will be discharged from service if they do not secure the requisite benchmark of 35% marks for General Category and 30% marks for Reserved Category, in requisite test/s within aforesaid period of one year.

They are further directed that their appointment is purely temporary and their services are liable to be terminated without any previous notice at any time. In case they want to resign the post, they will have to give one month's notice, failing which they shall have to pay one months salary.

They are also given to understand that on their appointment to the Government Service on or after 1st November, 2005 they would be covered under new "Define Contribution Pension Scheme" and the existing pension scheme i.e. Maharashtra Civil Services (Pension) Rules, 1982 and Maharashtra Civil Services (Commutation of Pension) Rules, 1984 and General Provident fund will not be applicable to them.

The above candidates shall not be entitled to claim any joining time, joining time pay and allowances and T.A./D.A. in connection with their appointment.
