In this regard, if no communication is received from their end within 30 days of the receipt of this order, it will be presumed that they are not interested to join the duties and their names shall be liable to be struck off from the Select List.

The above candidate at Sr.No.1 will be appointed on ad-hoc basis subject to condition that, he will have to pass the English and Marathi Shorthand test mentioned against his name in Select List within a period of one year from the date of his appointment.

The above candidate at Sr.No. 1 will be discharged from service if he do not secure the requisite benchmark of 35% marks for General Category and 30% marks for Reserved Category, in requisite test/s within aforesaid period of one year.

The above candidates are further directed that their appointment is purely temporary and their services is liable to be terminated without any previous notice at any time. In case they want to resign the post, they will have to give one month's notice, failing which they shall have to pay one months salary.

They are also given to understand that on their appointment to the Government Service on or after 1<sup>st</sup> November, 2005 they would be covered under new "Define Contribution Pension Scheme" and the existing pension scheme i.e. Maharashtra Civil Services (Pension) Rules, 1982 and Maharashtra Civil Services (Commutation of Pension) Rules, 1984 and General Provident fund will not be applicable to them.

The above candidates are directed that, after joining the duty they shall take over the detailed charge of their respective posts and submit the details charge report to this office forthwith.

The above candidates shall not be entitled to claim any pay and allowances and T.A./D.A. in connection with their appointment and transfer.
