

Id-Ul-Zuha dated 07-06-2025, Janmashtmi dated 16.08.2025 falls on Saturdays and Republic Day dated 26.01.2025, Gudi Padwa/Chaitichand dated 30.03.2025, Ramnavmi dated 06.04.2025, Moharrum dated 06.07.2025, Sarv Pitra Moksha Amavasya dated 21.09.2025 falls on Sunday therefore these holidays are not declared separately.
2. Saturdays falling on 4<sup>th</sup> & 18<sup>th</sup> January, 1<sup>st</sup> & 15<sup>th</sup> February, 1<sup>st</sup> & 15<sup>th</sup> March, 5<sup>th</sup> & 19<sup>th</sup> April, 3<sup>rd</sup> May, 7<sup>th</sup> & 21<sup>st</sup> June, 5<sup>th</sup> & 19<sup>th</sup> July, 2<sup>nd</sup> & 16<sup>th</sup> August, 6<sup>th</sup> & 20<sup>th</sup> September, 4<sup>th</sup> & 18<sup>th</sup> October, 1<sup>st</sup> & 15<sup>th</sup> November, 6<sup>th</sup> & 20<sup>th</sup> December will be closed Saturdays of District Judiciary.
3. Saturday falling on 17<sup>th</sup> May 2025 shall be working day for the District Judiciary.
4. Summer Vacation of District Judiciary shall be from 19<sup>th</sup> May, 2025 to 13<sup>th</sup> June, 2025 and Winter Vacation from 24<sup>th</sup> December 2025 to 31<sup>st</sup> December, 2025.

5. District Judiciary will not observe the holidays declared or changed suddenly by the State Government/Competent Authority without approval of High Court.
6. The Principal District Judge of the concerned district shall declare three Local holidays declared by the Collector/Commissioner of the concerned District or Tehsil without approval of the High Court under intimation to this Registry.
7. Due to uncertainty relating to Id-Ul-Fitar, Id-Ul-Zuha, Moharrum, Id-Milad un-Nabi or any other holiday, the same may be modified as directed by Hon'ble Chief Justice.
