- 3. Bids received after the due date and time and the incomplete ones shall be rejected out rightly. Conditional quotations will not be considered.
- 4. The Company / Firm must have GST Registration, PAN, Bank Account. Supporting documents must be enclosed.
- 5. The intending tenderer (s) must furnish copies of Income Tax return for the last three years & other documents to show turnover of the said period.
- 6. Rates quoted should be inclusive of all applicable charges, taxes, duties and levies. No other claim / allowances will be entertained / paid for such on-spot service / work.

Tenderers will have to attend along with original copies of documents. In case of inability of the tenderer only one representative will be allowed to attend subject to presentation of authorization letter.
