SERVICES THAT ARE BEING PROVIDED TO DIFFERENTLY ABLED PERSONS:

1. Disabled lawyer can opt for e-filing. Presently, physical filing is the norm and even though a lawyer may navigate through this process with the help of his attorney/clerk, everyone cannot afford this luxury. Further, placing the onus on the disabled lawyer to do so is inconsistent with the text and objects of the Rights of Persons with Disabilities Act, 2016. In order to effectual this, this office will maintain a list of disabled lawyers practicing in this Court. The disabled Advocates are requested to get enter their name in the list. As soon as a lawyer whose name is in such a list, the option of digital filing should become available to him/her. Under this option, the entire proceedings should go to the digital route.
2. Wheel Chair is available in the Warandah of District Court for disabled persons.
