**NOTIFICATION**

Applications are invited from the eligible candidates upto 5.00 P.M. on 06.02.2026 in the format enclosed herewith for appointment to **One vacant post of Court Attendant** in the Court of Special Judicial Second Class Magistrate at Thorrur.

The Applications shall be submitted through Registered Post or through Courier to "**The Principal District and Sessions Judge, Mahabubabad**" and the application forms will not be entertained either directly or in person.

The term of the post of Court Attendant is (02) years and shall be paid Honorarium/remuneration @ **Rs.3,000/- per month.**

**The Vacancy position of the posts :**

**Eligibility criteria for the post of Court Attendant :**

- (i) Any retired person who held the post of Office Subordinate or in any other post in the Last Grade Service in the Subordinate Courts or the High Court service.

Provided that, if suitable retired employee from the Last Grade Service in the Subordinate Courts and the High Court Service does not respond to the recruitment notification or otherwise not available, an outsider can be appointed, if he possesses the following qualifications :

- a) Must have passed 7<sup>th</sup> class examination or any equivalent examination.
- b) Who have completed the age of 18 years and must not have completed the age of 34 years as on 1/7/2026. The relaxation of maximum age limit is 5 years in respect of SC/ST and BC candidates and 10 years in respect of Physically challenged and Ex-Service men.

Preference will be given to the local candidates, i.e., persons living in the same station or near about place and Rule of reservation need not be followed.

**General Instructions :-**


1. Attested copies of Academic qualification and document evidencing Date of Birth shall be enclosed.
2. One recent passport size photograph of the applicant is to be affixed at the top of the application in the place specified.
3. Retired employees are to produce Retirement Proceedings.
4. Applications to be submitted in enclosed proforma and applications received in any other format will be summarily rejected.
5. No T.A. will be paid for candidate for journey performed in connection with recruitment.
6. Applications with insufficient information will be summarily rejected
7. Applications which do not contain necessary enclosures as detailed above will be rejected.
8. Applications received after 5.00 P.M. on the date prescribed above will not be considered.
9. The Office is not responsible for any postal delay, delay caused by any other service like courier or delay in delivery etc. and no correspondence will be entertained in any respect.
10. Candidate resorting to bring any influence of any kind will be summarily disqualified.
11. The appointing Authority reserves the right to cancel the Notification without assigning any reason thereof.
12. The appointments to the above posts is purely temporary basis on payment of monthly honorarium for a period of two years and the outsiders appointed for the said posts do not confer any right for future employment on regular basis.
