
TERMS & CONDITIONS:

2. The bidder shall have valid registration or trade license and GST to carry / supply the item in quotations. (Shops and Establishment Registration or Sale Tax act (GST) registration or Registered under certain enactment or any other certificate issue by Government or Government Agency).
3. The vendor must have PAN No. and Bank Account in any of the Nationalized Banks/Scheduled Banks. (In case of Ltd./Pvt.,



/Partnership Firm, the PAN and Account shall be in the name of the Firm/Company and in case of individual ownership, the PAN and Account may be in the name of owner).

4. While submitting the tender for this work, the tenderers will be deemed to have read, understood and accepted all the terms and conditions stated in the tender document and shall be complied with by the tendering firm.
