NOTIFICATION

Pursuant to the Orders of the Hon'ble High Court vide ROC.No.496/E1/2019 dt. 22-07-2022 and G.O.Ms.No.104 Finance (HRM.II) Dept. Dt. 30-12-2019, applications are invited from the Retired Judicial Ministerial Employees to fill up the below mentioned Posts in the Fast Track Special Court for Expeditious Trial and Disposal of Rape and POCSO Act cases established at Sangareddy in the Unit of Sangareddy purely on Contract basis.

The application should be in prescribed Proforma appended hereto to be submitted directly to the District Court, Sangareddy District on or before 8-08-2024 by 5.00 PM.

Note:

The appointment of Retired Judicial Employees is subject to the following conditions.

- i) Only persons who have retired from the Judicial Ministerial Services are eligible.
- ii) Ministerial Staff who have retired on attaining the age of superannuation and who have not attained the age of 65 years.
- iii) Ministerial Staff having satisfactory record of service.
- iv) The candidates have to produce the Medical fitness certificate and Should be physically and mentally fit to hold the post. The term of re-employment will be determined from time to time by the Unit Head.
- v) The employee who was dismissed, removed and compulsorily retired or made to seek retirement on medical grounds are not eligible for the employment.
- vi) The employees who are re-employed shall be entitled to such consolidated remuneration as may be determined from time to time by the Government/H.O.

- vii) The re-employed shall be required to discharge their duties sincerely and honestly to the satisfaction of the Presiding Officers.
- viii) The services of the re-employed employees are liable to be terminated at any time without assigning any reasons and without any Notice and the appointment is purely temporarily and on Contract basis.
- ix) On appointment the appointees shall enter into an Agreement with the Unit Head initially for a period of (01) year subject to removal for a further period from time to time at the discretion of the Unit Head.
- x) The applications should submit their Service Certificates.

ELIGIBILITY:

- i) The outsiders possessing the required applications may also apply for above posts. However their candidature will be considered in the event of non availability of Judicial Employees.
- ii) Nationality: The candidate should be an Indian National.
- iii) Educational Qualifications: Must be a Graduate from any Recognized University, Shorthand-Lower/Higher in English, Typewriting English Lower/Higher.
- iv) Age Must have completed the age of 18 years and must not have attained the age of 34 years.
- v) Local Candidate Preference shall be given to the Local candidates i.e. Persons living in the same Station.
- vi) The candidates should not be involved in any Criminal cases.


Attested copies of the following should be enclosed to the application:

- i) Certificates of Academic and Technical Qualifications and other certificates to prove their professional skills if any.
- ii) Certificate evidencing Date of Birth.
- iii) Community Certificate in case of SC/ST/BC candidates.
- iv) Physical fitness certificate issued by Competent Authority.
- v) Any other relevant certificates i.e. retirement proceedings i(in case of retired Judl. Employees)
- vi) One recent passport size photograph of the applicant duly attested by the Gazetted Officer to be affixed at the top of application in the place specified.
- vii) The application should be addressed to the Principal District and Sessions Judge, Sangareddy.

GENERAL INSTRUCTIONS:

- i) No T.A. or D.A. will be paid for the journey performed in connection with recruitment.

- ii) The postings and transfers of the employees re-employed shall be at the discretion of the undersigned as required and necessitated by administrative exigencies subject to overall supervision of Hon'ble High Court of Telengana.
- iii) The appointed candidates shall be entitled to such consolidated remuneration as may be determined from time to time by the Government/Hon'ble High Court of Telangana.
- iv) The appointed candidate shall be required to discharge their duties sincerely courteously and honestly to the satisfaction of the presiding officers.
- v) On appointment, the employees shall enter into an agreement with the District Judge, Sangareddy initially for a period one year, subject to renewal for a further period from time to time at the discretion of the appointing authority and subject to continuance of the concerned courts.
