

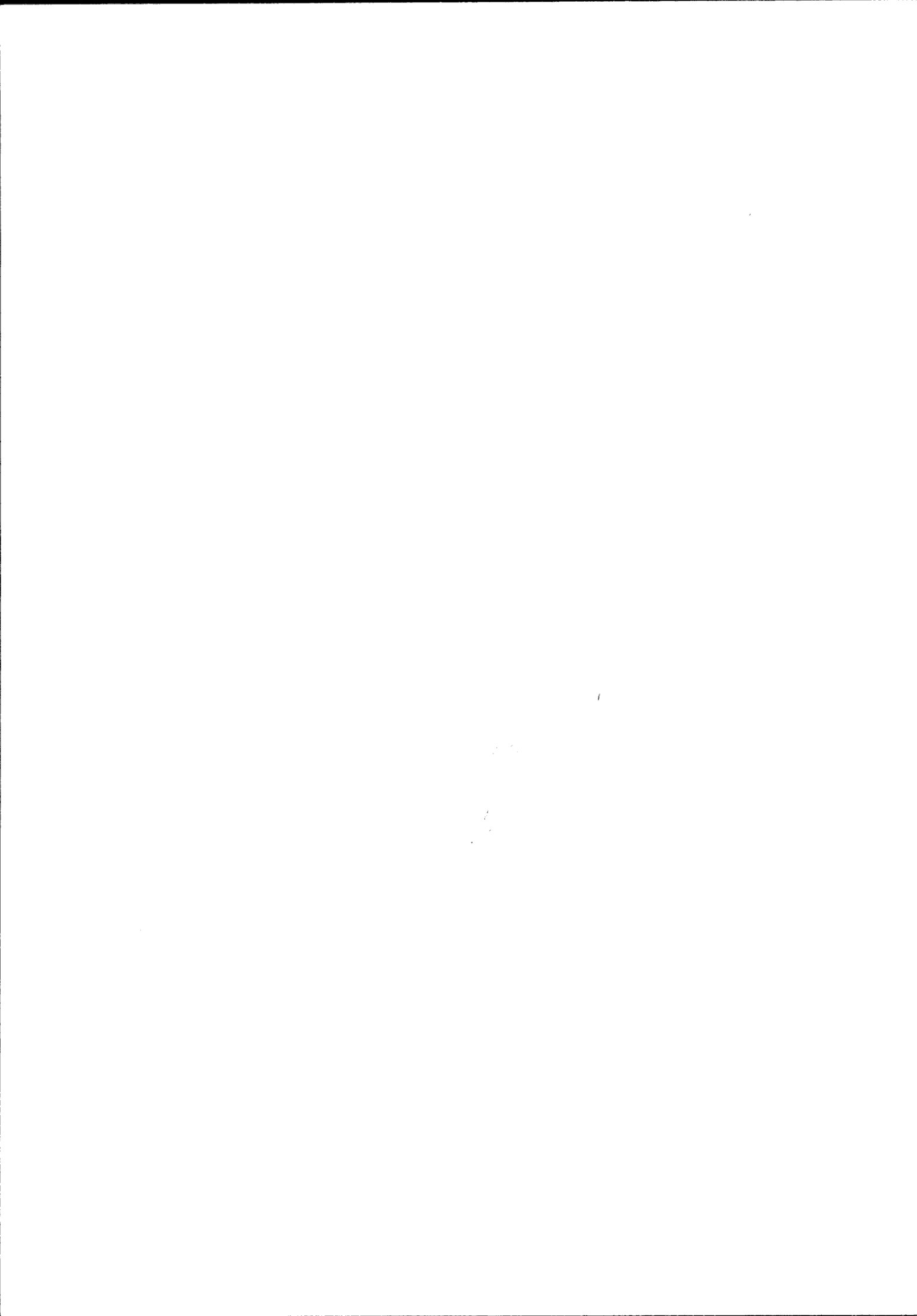

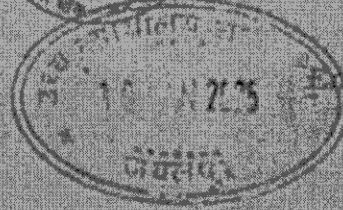

Dear Mr. Singh,

May kindly refer to your DO letter no 366/2024 regarding poor condition of service of summons and warrants in the state.

The summon and warrant data attached with your letter was analyzed with the data available with us. We have found that there is a discrepancy in both the data sets. This discrepancy has always been there.

As you are aware that BNSS has incorporated the use of digital technology and the Madhya Pradesh electronic processes (issuance, services and execution) rules 2024 has been notified which enables the digital issuance and service of court processes.

However, despite the notification of the rules the district police is still receiving physical summons and warrants. You would appreciate that this leads to not only duplication of work but also results in mismatched data sets.

Through this letter I would request that the trial courts are directed by your office to adhere to the MP electronic processes rules 2024 and issue summons and warrants digitally only.

I also wish to reiterate that the whole of Madhya Pradesh Police is fully committed and shall take every step to serve the E summons and warrants issues by courts.
