NOTICE INVITING APPLICATIONS FOR ENGAGEMENT AS FULL TIME LEGAL AID LAWYERS IN LEGAL AID DEFENCE COUNSEL OFFICE IN DISTRICT LEGAL SERVICES AUTHORITY, MEDAK.

Sub:- DLSA, MEDAK - Implementation of Legal Aid Defence Counsel System (LADCS) Scheme as per approved EFC Memorandum - Filling of One Assistant Legal Aid Defence Counsel, Medak - Notification - Issued - Regarding.

The State Legal Services Authority, established under the Legal Services Authorities Act, 1987 with mandate to provide free and competent legal services to the underprivileged and disadvantaged sections of the society to ensure that opportunities for securing justice are not denied to any citizen by reason of economic or other disabilities and to secure that the operation of the legal system promotes justice on a basis of equal opportunity to all.

Realising the need to ponder over the reforms required in the Legal Aid Movement of India a new model of Legal Services Delivery, the 'Legal Aid Defence Counsel System' (LADCS), in line with public defender system, is introduced by NALSA. As envisaged, LADCS involve full time engagement of lawyer with support system, in the cadre of Assistant legal Defence Counsel, dealing exclusively with legal aid work in criminal matters at every stage starting from the pre-arrest, arrest & remand stage to the conclusion of trials and appeals etc. It will enhance the availability and accessibility of Legal Aid in a timely manner and help in creating a mechanism to provide qualitative and competent legal services in a professional manner to underprivileged and disadvantaged section of the society.

Hence, applications are invited from eligible lawyers having requisite qualifications for Contractual full time engagement for the post of Assistant Legal Aid Defence Counsel. The Lawyer so engaged therein will not be allowed to take any other private cases or any other retainership.

- a) Qualification for Assistant Legal Aid Defence Counsel:.
 - Practice in criminal law from 0 to 3 years.
 - Good oral and written communication skills.
 - Thorough understanding of ethical duties of defence counsel.
 - Ability to work effectively and efficiently with others.
 - · Excellent writing and research skills.
 - IT Knowledge with high proficiency in work.

Note: Qualifications may be reasonably relaxed in case of exceptional candidates or circumstances with the approval of the Executive Chairman SLSA.
