

Sir/Madam,

With reference to the subject cited above, I am directed to inform that there has been a rampant usage of packaged drinking water bottles in official meetings, public meetings and social gatherings. Further, considering the damage to the environment caused by extensive use of packaged drinking water bottles and banned Single Use Plastic (SUP) items, the Hon'ble Chief Minister, Assam, desires to stop usage of packaged drinking water bottles across all Departments in the State of Assam including Educational and Research Institutes, Public Sector Undertakings, Autonomous Bodies as per Cabinet decision on 21/7/23.

In view of the above, all Departments are hereby directed the following:

1. To prohibit usage of packaged drinking water bottles and banned SUP items in meetings and functions of all Government Departments and their sub-ordinate offices/organisations, Educational and Research Institutes, Public Sector Undertakings, Autonomous Bodies etc including those programs held in venues outside the office premises with immediate effect.
2. As an alternative, it is suggested to use drinking water from large dispensers or reusable water bottles and use reusable or eco-friendly crockery and cutlery instead Single Use Plastic (SUP) items.

Further, all senior most Secretaries are hereby requested to take actions enthusiastically for eliminating single use plastics from their departments in order to set an example for the public across the State of Assam. Necessary instructions may also be given to all Training Institutes/Centers, Educational and Research Institutes/ Public Sector Undertakings/Autonomous bodies/Local Bodies etc under their administrative jurisdiction accordingly.

The General Administrative Department is requested to equip all meeting/conference halls in Janata Bhawan with drinking water dispensers and also ensure availability of drinking water and reusable glass / paper cups along with the dispensers during meetings.
