Applications are invited in Standard Form as published in Assam Gazette in Part IX from the eligible candidates who are citizens of India as defined in Articles 5 and 8 of the Constitution of India for engagement of 01 (one) number of Office Assistant and 01 (one) number of Peon in the Office of the Legal Aid Defence Counsel System (LADCS), Baksa under District Legal Services Authority, Baksa at Mushalpur. The engagement shall be purely on contractual basis which will be for a period of 01 (one) year. The Contract period may be extended depending upon requirement and performance which shall be subject to the approval of the Assam State Legal Services Authority, Guwahati-01.

**Selection Procedure:** For 1 (one) No. of Office Assistant, all accepted applicants will be called for to appear in a Computer Skill Test. The Selected Candidates from the Computer Skill Test will be called for an interview/ Viva Voce. The final merit list will be prepared on the basis of the sum total of marks obtained in the Computer Skill Test and Interview/Viva Voce.

For 1 (one) No. of Peon, all accepted applicants will be called for to appear in an interview / Viva Voce. The final merit list will be prepared on the basis of the total marks obtained in the Interview/Viva Voce.

**How to apply:** Candidates are required to submit their Applications directly to the Office of the District Legal Services Authority, Baksa at Mushalpur.
