ELIGIBILITY:

- 1. The candidate must be an Indian Citizen.
- 2. The candidates must be a member of SC/ST(H) or OBC/MOBC.
- 3. The candidate must possess the minimum educational qualification of VIII Standard.
- 4. The candidate must possess a valid Driving License issued by the competent authority.
- 5. The candidate must not be less than 18 years and more than 40 years of age as on the date of application. The upper age limit will be relaxed by
 - a. By 5 years for ST and SC candidates i.e. up to 45 years as per Govt. Notification No.-ABP.6/2016/51, dated. 02-09-2020 issued by Department of Personal, Government of Assam.
 - b. By 3 years for OBC/MOBC candidates i.e. up to 43 years as per Govt. Notification No.-ABP.6/2016/51, dated 02-09-2020 issued by Department of Personal, Government of Assam.

HOW TO APPLY:

- Eligible candidates will have to apply in Standard Form of Application (Published in the Gazette Part-IX of Govt. of Assam) addressing on the top of the envelop as "Application for the post of DRIVER" and must submit to "The Office of The Chief Judicial Magistrate, Baksa, District Judicial Court Complex, Bathouphuri, Mushalpur-781372". The Last date of receipt of application is 16-07-2024 till 5.00 PM.
- 2. The application must be accompanied with the following
 - a. Three recent coloured Passport size photograph with name on reverse side.
 - b. One self-addressed Envelope affixing postage stamp of Rs. 5 thereon.
 - c. Self-attested copies of testimonials in support of his/her AGE, CASTE, EDUCATIONAL QUALIFICATION, DRIVING LICENSE.
 - d. Mobile nos. must be written on the top of the Standard Form in RED INK.
- 3. Candidates already in Govt. service must apply through proper channel.
- 4. Incomplete or late received applications will summarily be rejected.
- 5. If any candidate found canvassing directly/indirectly his/her candidature will be rejected.
- 6. The applications can be submitted through Ordinary/Speed/Registered Post or by directly to the office of the undersigned.

SELECTION PROCEDURE:

The candidates will have to appear in Driving Test and an Interview (Viva-Voce) at their own expenses. The selection will be made purely on merit basis. Canvassing directly or indirectly by any candidate will lead to cancellation of his/her candidature.
