How to Apply:

- 1. Candidates who fulfill the requisite eligibility criteria can submit their application in prescribed Standard Form of Application published in the Assam Gazette Part-IX and fill all the fields in block letter.
- 2. Paste one recent passport size coloured photograph in the specified box.
- 3. Put signature in the specified place.

Eligibility Criteria

- 1. The candidates must have to pass minimum Class VIII.
- 2. Applicant must have to enrolled Employment Exchange and should have valid Registration Card and valid **Driving License(LMV)** as on the date of application.
- 3. Applicant must not be below 18(eighteen)years of age as on 01-01-2024 and not more than 40 years. The upper age limit is relaxable by 5 years for SC/ST(P)/ST(H) and 3 years for OBC/MOBC candidates as per Govt of Assam memorandum vide No.ABP.6/2016/51 dtd 02-09-2020.

Note:- The candidates who have applied earlier fulfilling the above criteria as per advertisement dtd 15-06-2024 of this establishment need not to apply again.

Terms and Conditions:

- 1. The filled up Application Form along with all copies of self attested documents like Age proof certificate, Educational Qualification certificate, valid Driving Licence(LMV) issued by District Transport Officer, Caste certificate(if applicable) from competent authority, Employment Exchange Registration certificate along with 2(two) recent passport sized photographs must be dropped in the "Drop Box " placed in the office premises of the undersigned or can email to recruitmentbaksajudiciary@gmail.com in pdf format or by post addressing as "The District & Sessions Judge, Baksa Mushalpur, Pin No.781372, BTR,(Assam)"
