How to Apply:

- 1. The intending candidates may submit their application in sealed envelope by hand, speed post/courier addressed to the "District & Sessions Judge, Baksa, Mushalpur, Pin- 781372" in Drop Box placed at the office premises of the undersigned on or before 15-11-2025 by 04:30 P.M. No other mode of submission of Application Forms will be entertained. Applications received after the said date and time shall not be considered. The office shall not be responsible for any postal delay and such application will not be accepted shall rejected summarily.
- The filled up application Form must superscribe "Application for the post of Driver (Contingent) on the top of the envelope. Candidate shall mention their Mobile/ Whatsapp Number and e-mail ID(if available) on the top of the Standard Form.
- 3. The application/Standard Form of the candidates shall be accompanied with:
 - (a) Self attested copies of all testimonials in support of their educational qualification, Driving License, Age proof and employment Registration Certificate.

- (b) **02(two)** copies of recent passport size coloured photographs duly signed by the candidates on the reverse side.
- (b) Self attested copy of Employment Exchange Registration Card of the candidate.

Terms and Conditions:

- The candidate should have the knowledge of Official language of the state of Assam.
- 2. The candidate must **not be less than 18 years and above 40 years** of age. The relaxation of age shall be made as per Govt. OM vide No.ABP.6/2016/52 dated 02-09-2020 and the **determinative date shall be 01-01-2025**.
- 3. The candidate must have valid Light Motor Vehicle(LMV) Driving License issued by the competent authority. Candidates must have at least 03 years experience in Driving.
- 4. No individual call letter shall be issued to the candidates. Candidates are advised to visit the official website (https://baksa.dcourts.gov.in) regularly for update information. Unnecessary correspondence should be avoided and if done, candidature will be rejected.
- 5. Any incomplete application form in any respect, such as, without photograph, signature and lack of supported documents etc. to be rejected summarily.
- 6. Applicants those who are already in government service should submit their applications through proper channel along with No Objection Certificate with the application and they are to submit release order at the time of joining from their employer, if selected.
- 7. Information submitted by any applicant in their application will bind the candidate and if found to be false, their candidature will be canceled forthwith and if detected at any time after selection, the service will be terminated without serving notice.
- 8. The list of shortlisted applicants will be uploaded in the official website of Baksa District Judiciary i.e. https://baksa.dcourts.gov.in along with the date of Driving/Skill Test.
- Shortlisted eligible candidates shall have to appear for the Skill/Driving Test.
 Candidates qualified in the Skill/Driving Test will be called for document verification and viva-voce/interview.
- 10. All other information relating to the engagement process(including final results) will be published in the official website of Baksa District Judiciary i.e. https://baksa.dcourts.gov.in
- 11. The last date of receipt of application is 15-11-2025 by 4:30 P.M and tentative date of Skill/Driving test is 30-11-2025.
- 12. Canvassing directly or indirectly shall disqualify a candidate.
- 13. Applications made in any other mode except as indicated above shall be summarily rejected without any communication.
- 14. The inclusion of candidate's name in the list of Skill/Driving test shall confer no right to appointment unless the Appointing Authority is satisfied after such enquiry as may consider necessary that the candidate is suitable in all respect for appointment.
- 15. The person, who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be ineligible for appointment to the aforementioned

posts and if come to notice of such fact even after selection, his/her service shall be terminated immediately without serving any notice..

- 16. No T.A./D.A. will be admissible to the candidates for appearing in the Skill/Driving Test as well as Viva-voce/oral interview.
- 17. Candidate will be responsible for any mistake made by him/her in the application form.
- 18. The applicant and his family members should neither beneficiaries of the Orunudoi Scheme or have voluntarily opted out as on the date of appointment/ engagement as per Govt.O.M. No.E.Comp.147229/367 dtd 30-12-2024.
