**Order No. 48/2024 (Administrative)**

As per directions contained in the calendar issued by the Hon'ble High Court, Allahabad for use in the subordinate court during the year 2024, Hon'ble High Court has empowered to the District Judges to declare 05 local holidays and if any National or other holidays mentioned in the calendar falls on 2nd Saturday or on a Sunday, additional day(s) be declared as holidays on its place.

Since, on 24.03.2024 & 13.10.2024 have been declared holidays on account of Holi & Dussehra, respectively and the same falls on Sunday, hence, abiding by the direction of the Hon'ble Court, 02 additional days are also being declared as holiday in addition to 05 local holidays.

Therefore, following local holidays and additional holidays are being declared in this Judgeship with consultation of District Magistrate, Barabanki.




