Apropos to the subject mentioned above and order under reference, I am to inform you that as per the directions of Hon'ble Apex Court in the above referred order, a Committee headed by the Undersigned has been formed. The Hon'ble Apex Court, in para No. 26 & 28 of the said order has directed the said Committee to decide the issue of entitlement to interest, to take help of the Para Legal Volunteers to reach the persons who have been deprived of compensation and to render assistance to them or their LR's to comply with the procedural formalities.

The Committee has resolved to issue Public Notices as a last resort to trace out the LRs of such missing/dead persons. Such Public Notices are published in State of Maharashtra in English, Hindi and Marathi newspapers. Same are published on website of Collector, Mumbai City, Collector, Mumbai Suburban as well as on official website of this Authority. Similarly, wide publication will be given by sending the same to the offices

of Superintendent of Police of each concerned District, Tahsildar and all concerned police stations.

Accordingly, you are also requested to give wide publicity to Public Notices in your State by:

- (i) Publishing it in newspapers having wide circulation.
- (ii) Publishing it at your official website.
- (iii) Forwarding the same to the concerned Collector office, Police Stations and other Government/Public Offices.

The Public notices and lists of missing/dead persons are annexed herewith for further action.

Kindly treat this as MOST URGENT and report the compliance at the earliest.
