- 2) Rates should be quoted taking into account the description/make/Type/specification mentioned above in the table for total quantity of work for which quotations have been invited.
- 3) Rates quoted should be inclusive of all applicable charges, taxes, duties, levies and GST etc. if any.
- 4) The intending participants shall have to submit his Trade Licence, PAN etc. along with his quotation.
- 5) Conditional quotations will not be considered.
- 6) The Intending participants shall have to quote his price both in figures as well as words in the Quotation.

7) The intending participants shall have to specify on the envelop "quotation for" along with the address of its office and its phone/mobile number, if available, for the purpose of quick communication in the event of urgency

8) Canvassing on the part of the supplier submitting quotation will render its quotation liable to cancellation summarily.

9) This Judgeship may award the contract to the supplier whose quotation has been resolved to be substantially responsive and who has quoted the lowest evaluated price. However, this Judgeship is not bound to accept the lowest bid.
