Applications are hereby invited in Standard Form of application published in part -IX of Assam Gazette, from intending candidates for filling up **(01) One Post of Grade IV Peon** in the establishment of District and Sessions Judge, Sonitpur, Tezpur, in the Pay Band & Grade Pay with other allowances as admissible under Govt. of Assam rules as shown below:

Terms and Conditions :

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates must have registered their names in the Employment Exchange of Assam and valid Registration number along with date must be mentioned in the application.
3. Candidates serving in Govt. Department should submit their application through proper channel.
4. If any candidate is found to have suppressed his educational qualifications or given wrong information at the time of applying for job or later on, his candidature shall stand rejected and also shall liable to Criminal Prosecution as per law.
5. Candidates must not be less than 18 years or more than 40 years of age as on **01.01.2026**. The Upper Age is relaxable as per Govt. norms.
6. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card along with 3 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side should reach the Office of the District and Sessions Judge, Sonitpur, Tezpur.

7. The applicants shall mention their **Mobile Numbers** in the application form **without fail**.
8. The last date of receipt of application form is 10 days from the date of publication of this advertisement in the official website of District Judiciary, Sonitpur. No application will be entertained after the last date. The appointing authority shall not be responsible under any circumstances for any postal delay.
9. The eligible candidates shall be required to appear for interview/viva-voce which will be intimated in due course of time.
10. Envelope containing the application should indicate the name of the post applied for in Block letters as - **"APPLICATION FOR THE PEON (GRADE IV) "**

12. No person who has entered into or contracted a marriage with a person having a spouse or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the aforesaid post of Peon.
13. Candidates at the time of applying shall have to submit a **Declaration in Form "A"** under Rule 5(1) of the Assam Public Services (Application of Small Family Norms in Direct Recruitment) Rules, 2019.
