Application in Standard Forms are invited from intending male candidates for engagement against **ONE** (Unreserved) temporary post of DRIVER (on contingency basis) in the establishment of the undersigned on **FIXED PAY** of Rs. **15,000/-** (Fifteen Thousand) per month.

## **ELIGIBILITY:**

- 1) The Candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
- The Candidate must have a valid LMV Driving Licence issued by the competent authority.
- 3) The Candidate must not be less than 18 years and more than 40 years of age as on 01.01.2023. The upper age limit will be relaxed (i) By 5 years for ST and SC candidates i.e. up to 45 years as per the Govt. Notification No. ABP.6/2016/51, Dated 2<sup>nd</sup>September, 2020 issued by the Department of Personnel, Government of Assam. (ii) By 3 years for OBC/MOBC candidates i.e. up to 43 years as per the Govt. Notification No. ABP.6/2016/51, Dated 2<sup>nd</sup> September, 2020 issued by the Department of Personnel, Government of Assam.
- 4) Minimum Qualification of the candidate must be Class-VIII (Eight) Passed.
- 5) Preference will be given to experienced candidates.

#### **HOW TO APPLY:**

1) Eligible candidates will have to apply in Standard Form of Application (published in the Gazette Part IX of Govt. of Assam) and same must be addressed to "The Chief Judicial Magistrate, Karbi Anglong, Diphu, PIN- 782460." The last date of receipt of application is 17.10.2023 till office working hours. No applications received thereafter will be entertained.



- 2) The applicant must superscribe <u>"APPLICATION FOR THE POST OF DRIVER"</u> on the top of the envelope and must write their MOBILE Nos. on the top of the Standard Form respectively in red ink.
- 3) The application must be accompanied with
  - a. Two copies of recent coloured passport size photo,
  - b. Experience Certificate, if any
  - c. All SELF ATTESTED testimonials in support of their educational qualification and caste.
- 4) Candidates already in Govt. service must apply through proper channel.
- 5) The candidates will have to appear in the Driving Test & Interview at their own expenses and no T.A. & D.A. is admissible in this respect.
- 6) All information about date of skill test and viva-voce shall be shared through SMS and Whatsapp. So, the candidates are asked to provide their phone number in their application forms.
- 7) The applications can be submitted through ordinary/Speed/Registered Post or directly to the office of the undersigned. The office will not be responsible for any postal delay.

### **SELECTION PROCEDURE:**

- The candidates who are found to be eligible shall have to undergo skill test of 50 marks.
- The candidates who qualify the skill test will be called for a viva-voce of 15 marks.
- 3) List of eligible candidates for skill test and for viva-voce will be uploaded in the official website www.districts.ecourts.gov.in or www.karbianglongjudiciary.gov.in (District Court-Karbi Anglong) in due course of time.
- 4) No separate call letters will be issued individually for the skill test and viva-voce.
- 5) The selection will be made purely on merit basis.
- If any candidate found canvassing directly/indirectly, his/her candidature will be rejected.
